### **Booking Conditions:**

1. Your cottage will be ready for you at 3pm on your arrival day, please do not arrive earlier unless by prior arrangement. Please vacate your cottage by 10am on your departure day.
2. All cottages are thoroughly cleaned between lettings. However time is always limited so please leave the cottage as clean and tidy as possible.
3. All breakages must be reported and/or paid for, furniture and effects in the cottages must be left in the same condition as when you arrived.
4. When a booking has been confirmed, you are responsible for the total cost of the holiday. It is your responsibility to ensure that any balance is received by us 6 weeks prior to your holiday start date, failing which, deposits will be forfeited and the holiday will be offered for re-sale, you will remain responsible for the balance of the holiday if the holiday is not re-sold.
5. Whilst all bookings are accepted in good faith by the owners, in the extremely unlikely event of any occurrence making it necessary to cancel the booking, the owner's liability shall be limited to the return of any deposit monies paid.
6. Only the number of persons confirmed in the booking are allowed per cottage unless by prior arrangement. Your rights to occupy the cottage may be forfeited without compensation if more people take up occupation, Overnight guests are entertained without permission, or any activity is undertaken which may cause unreasonable damage, noise or disturbance.
7. The use of the facilities and amenities on site are entirely at your own risk, and no responsibility can be accepted by the Owners for injury, loss or damage to you or your possessions including your vehicle.
8. Every effort is made to ensure that the facilities offered are available but we reserve the right, in the event of circumstances beyond our control to withdraw such facilities.
